# Jiangsu Eastern Shenghong: 2024 Semi-Annual Results and Provision for Asset Impairment

Suzhou City, China, August 29, 2024

Jiangsu Eastern Shenghong Co., Ltd. (the "Company") today reported half year financial results of 2024.

- During the reporting period, the Company achieved revenue of RMB 72,833,561,598.67, an increase of 10.46% over the same period last year (after adjustment), net profit attributable to shareholders of the listed company of RMB 318,574,372.31, a decrease of 81.59% over the same period last year (after adjustment). Net cash flows from operating activities accounts to RMB 2,020,427,905.56, a decrease of 74.57% over the same period last year (after adjustment). The changes in revenue, profit and cash flow were mainly due to the narrowing price difference of certain products and the increase of costs rising by depreciation and corresponding financial expenses of the ongoing construction capitalization.
- The provision for impairment of assets of Half Year 2024 decreased the total profit of the consolidated financial statement in Half Year 2024 by RMB 603.1318 million. The Company conducted a comprehensive examination and impairment testing of various assets as of June 30, 2024. Based on the testing results, the Company made provisions for impairment for assets where impairment indicators were identified.
